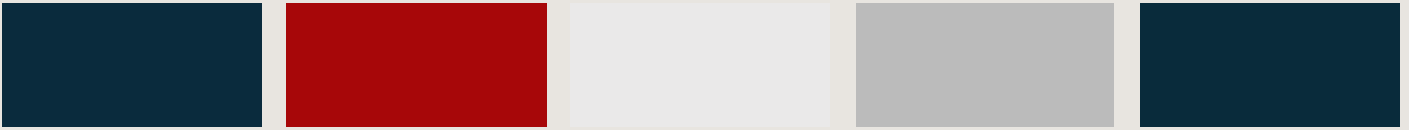

PAROLE IN PLACE

Parole in Place (PIP) is a discretionary option available in the United States that allows certain undocumented immigrants to stay in the U.S. or to adjust their status and obtain legal status without leaving the United States.

Introduction to Parole in Place (PIP)

To fully comprehend the value of the PIP program, one must understand the broader context of immigration law. For many, the road to lawful permanent resident status is a long and difficult one, due to relocation requirements or years-long statutory bars. This program is particularly valuable for individuals who would typically be required to process their immigrant visas at a U.S. embassy or consulate abroad and trying to re-enter the U.S. may trigger harsh penalties due to their prior presence in the United States without legal status.

The PIP program, presents a domestic solution that streamlines the process, eliminating the need for international travel and long waiting periods, which could be as lengthy as 10 years.

Established under the doctrine of prosecutorial discretion, PIP recognizes the unique situations of certain undocumented immigrants with family ties to the U.S. and provides them with a pathway to legal immigration. Its significance cannot be overstated, as it offers a way for spouses, parents, and children to remain together.
